SUPPLY AND DELIVERY OF THREE PHASE 4 WIRE LT CT CONNECTION SMART METERS FOR LIBERIA ELECTRICITY CORPORATION (LEC)

The United States of America, acting through the Millennium Challenge Corporation (MCC) and the Government of Liberia (GoL) have entered a Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Liberia (the “Compact”). The Government, acting through the Millennium Challenge Account-Liberia (MCA-Liberia), intends to hold a Pre-Solicitation Conference with interested suppliers/manufacturers to inform them about the up-coming requirement for the Supply and Delivery of Three Phase 4 Wire LT CT Connection Smart Meters for Liberia Electricity Corporation (LEC).

The Scope for the supply and delivery of Three Phase 4 Wire LT CT Connection Smart Meters is briefly described as below:

- Design, manufacturing, testing, supply and delivery of AC, 3 Phase, 4 Wire, -/5 Amps, CT operated fully Static and AMR compatible Tri - Vector Energy Meters for measurement of different electrical parameters including Active Energy (kWh/MWh), Reactive Energy (kVARh/MVARh), Apparent Energy (kVAh/MVAh) etc. for Energy Accounting and Audit purpose.
- The scope of supply shall cover all items including the cabinet which must be of high security and tamper proof and be prewired internally with test block, prepaid meter, breaker and CT's of required sizes.
- The prepaid meter, TTB, CT's and auto-breaker are to be provided and pre-wired inside the high security cabinet (metering panel).
- As per LEC requirement, all LV CT meters are to be prepaid meters with the ability to switch to post-paid functionality when required in the present future.

The Pre-Solicitation Conference will include presentations on the details of the three phase 4 wire LT CT Connection Smart Meters required, their technical specifications, on the technical qualifications and experience required of the suppliers and on important provisions of the Request for Quotation document.

The Pre-Solicitation Conference will be held on **December 17, 2019** at MCA-Liberia Office, F&F Building, UN Drive, Coconut Plantation, Mamba Point, Monrovia.

MCA-Liberia now invites interested suppliers/manufacturers to express their interest in participating in this Pre-Solicitation Conference. Interested participants can also attend electronically (via WebEx). In your response, please provide the name of your firm and of the representative who will attend, mode of participation (in-person or WebEx) including email address and mobile phone number. ***In-person attendance will be limited to only two representatives from each firm.*** MCA-L will then contact you with details of the schedule and provide an agenda of the topics that will be addressed.
